The corrections increased our overall Instructional expenses by close to \$40,000. Overall our FY21 Original Budget (approved by the board on June 29th). Our receipt of these grants was confirmed just days after our meeting. He indicated that we will remain in compliance if we approve this change. we are in better shape than the original budget indicated. We will not have to dig as deeply into our reserves as planned. **4a.** Approval of an LEA-Specific Educator License for <u>Christopher</u> <u>Johnson</u>. On Wednesday of this past week, one of our elementary teachers quit unexpectedly and will be leaving the area. It is particularly difficult to find a teacher who has both Montessori and State licensure. Finding such a teacher on such short notice is likely impossible. We did have the resume on file of Chris Johnson who has his Montessori credential and a Master's degree in Conflict Resolution. He has been working as an assistant teacher at another Montessori Charter school. I have checked his references which are very good (including his current employer). I think we are very lucky to have him. It is recommended that the Board grant him an LEA-SPecific Educator License for 3 years to give him time to complete a licensure program while teaching. However, the state recently provided a template that must be completed, approved by the board, submitted to the state and posted on the school website by August 1. - 6. Calendar Update: In January we approved the 2020-2021 school calendar with a start date of August 24. Recently, the state board of education approved amendments to Administrative Rule R277-419 Pupil Accounting adjusting the 180-day/990-hour requirements to provide more flexibility to districts and charter schools including waiving the 990-hour requirement if a district or charter submits a request for the 2020-21 school year only describing how it will ensure continuity of teaching and learning by providing high-quality instruction that includes blended learning and formative assessment strategies. We would like to push back the day of regularly scheduled classes by one week to August 31. Teachers will begin the year on their regular contract schedule and will use the extra week between August 24<sup>th</sup> and 28<sup>th</sup> of the original school year to 1) meet virtually or in person with students and parents who will be learning from home to create a plan that will best support that family. This is especially crucial for our younger elementary students and for students transitioning to Walden for the first time. 2) Bring students into school to administer academic assessments. We will administer our state-required assessments, as appropriate, during this time. This will allow teachers to better support student needs and learning when classes begin particularly since end of year assessment data is not available. 3) Distribute laptops and other devices to students before online learning begins. 4) Hold IEP and 504 meetings to adjust services and placements for students who have opted for distance or blended learning. 5) Provide training to students and parents on how to use our online resources.
